Petition under sections 10-12 of the Contempt of Court Act, 1971 for failure of Respondents to comply with orders/ directions dated _____passed in CWP No. _____in case titled as _____by the Hon'ble Punjab and Haryana High Court, Chandigarh _____ on the ground of _____ of by the _____.

MOST RESPECTFULLY SHOWETH:-

1. That the petitioners knocked the doors of this Hon'ble High Court to invoke the extra-ordinary Contempt Jurisdiction of this Hon'ble Court. The CWP No. _____of 2018 was filed by the said Petitioners against the _____ i.e. Respondent to _____. The True copy of order dated _____is Annexed as **Annexure P-1 (Colly)**.

It is most Relevant to bring in the knowledge of the Hon'ble High court that in the order passed by the Hon'ble Court in the earlier Writ Petition i.e. _____annexed with the present CWP no._____ the Respondents claimed that_____.

2. That it is important to state here that the said notifications have been quashed by the Hon'ble Supreme Court vide Judgment Dated _____in Civil Appeal No. _____, on the ground that the time gap in issuing declaration U/s 6(1) is more than one year from the date of Notification issued U/s 4 (1). So Section 4 Notification does not survive.

3. That the Aggrieved petitioners in spite of having ownership of the property which is being acquired by the said authorities are running from pillar to post to get their land released. Having no other way the present petitioners had also filed earlier the Contempt Petition No._____to redress their same grievances regarding release of their property (comprised in Khasra No._____, ' situated at _____, which does not seems to be justice done by the Respondents with the Petitioners, in view of the fact that the property of the innocent Petitioners have not been released in spite of the order/ directions of the Hon'ble

Supreme Court as well as the Pleasing order of the Hon'ble High Court at Chandigarh which has not been complied with. The True copy of the Order of the Hon'ble High Court of Punjab and Haryana dated _____ is Annexed as **Annexure.P-2**

It is not out of place to mention here that the Petitioners sent the Representation/ Notice to Respondents to release the Property of the Petitioner as per the order of the Hon'ble High Court, passed in view of the Order of the Hon'ble Supreme Court of India, but till date no revert/ response written/ oral has been received by the petitioners from the Respondents. Ultimately, the said property has not been released, violating the judicial Precedence as the Respondent take the judicial principles as granted as they feel like that no stringent action will not being taken against them, So, the petitioners urge for stringent action against the culprits and also to get their property released, in the interest of justice.

4. That the Petitioners have waited for the considerable time given by the Hon'ble High Court to the Respondents to release the property or take the action within __ month has elapsed, but still neither any action has been taken by the Respondents nor the property has been released, so in other words the Orders of the Hon'ble Supreme Court as well as Hon'ble High Court have been violated by such unscrupulous persons. So, it is crystal clear that the respondents are wilful guilty of Contempt of Court.

. It is, therefore, respectfully prayed that the petition may kindly be allowed, respondents may be suitably punished for non-compliance of the orders dated _____ passed by this Hon'ble High Court in CWP No. _____ and CWP No. _____, in accordance with the law.
